FEDERAL –

- March 2021 US Department of Interior launched review of federal oil and gas leasing program
 - Kicks off public forum on oil and gas leasing to generate an interim report released early summer 2021 outlining next steps and recommendations.
- Climate Leadership and Environmental Action for our Nation's Future Act - "CLEAN Future" Act – filed in Congress on March 2021.
- Revive Economic Growth and Reclaim
 Orphaned Wells Act "REGROW Act" filed in Congress April 2021
 - Providing states, tribes, and federal agencies resources to properly plug orphaned wells.
- Dakota Access Pipeline
 - Army Corps is conducting an environmental and safety review expected to be complete in early 2022. Current administration has indicated the pipeline can continue to operate while the review is in progress.
