## NOTICE OF TRANSFER OF CRUDE OIL OR PRODUCED WATER UNDERGROUND GATHERING PIPELINES - FORM 15PL SFN 61176

- 1. Please refer to Section 43-02-03-15 of the North Dakota Administrative Code regarding transfer of underground gathering pipelines.
- 2. The owner of a pipeline shall be the principal on the bond covering the pipeline.
- 3. The owner, underground gathering system name, and pipeline name shall coincide with the official records on file with the Commission.
- 4. Transfer of property does not release the bond. In case of transfer of property or other interest in the underground gathering pipeline and the principal desires to be released from the bond covering the pipelines, the principal shall notify the Director, in writing, on a Notice of Transfer of Crude Oil or Produced Water Underground Gathering Pipelines - Form 15PL (SFN 61176) at least thirty (30) days before the closing date of the transfer. The Director, for good cause, may waive the requirement of at least thirty (30) days' notice prior to transfer.
- 5. The date of assignment or transfer shall be reported.
- 6. When the Commission has approved the transfer and accepted it under the transferee's bond, the transferor shall be released from the responsibility of abandonment of the underground gathering pipelines and right-of-way reclamation.
- 7. The transferee (new owner) of any pipeline shall be responsible for the abandonment of the underground gathering pipelines and right-of-way reclamation. For that purpose the transferee shall submit a new bond or, in the case of a surety bond, produce the written consent from the surety of the original or prior bond that the latter's responsibility shall continue.
- 8. The surety company shall be a responsible surety company authorized to transact business in North Dakota.
- 9. The bond number in the surety block is a number assigned by the surety company.
- 10. The Commission may refuse to transfer pipelines if the transferring owner, receiving owner, or surety company has failed in the past to comply with statutes, rules, or orders relating to the operation of underground gathering pipelines; if a civil or administrative action brought by the Commission is pending against the owner or surety company; if an underground gathering pipeline system has exhibited multiple failures; or for other good cause.
