#### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

Pursuant to legal notice this cause came on for hearing at 9:30 a.m. on the 13th day of August, 1974, at Bismarck, North Dakota, before the Industrial Commission of North Dakota, hereinafter referred to as the "Commission."

NOW, on this 10 d day of Systember, 1974, the Commission, a quorum being present, having considered the testimony adduced, and the exhibits received, at said hearing, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given, as required by law, the Commission has jurisdiction of this cause, and the subject matter thereof.
- (2) That Earl Schwartz dba Gofor Oil, Inc., and Earl Schwartz Company, is the operator of the following wells in the Mohall Field, Bottineau County, North Dakota:

- (3) That the above-described wells were shut-in by Commission Order No. 1284, for failure to comply with certain of the rules of the Commission.
- (4) That testimony given at said hearing indicates that all of the abovelisted wells except the Carl Gilseth #1 and the Ivan Gehringer Tr-2 #1 are in

compliance with the rules and should be allowed to resume producing.

- (5) That minor amounts of work need to be completed before the Carl Gilseth #1 and the Ivan Gehringer Tr-2 #1 are in compliance, and applicant stated that such work would be done.
- (6) That the Carl Gilseth #I and the Evan Gehringer Tr-2 #1 should be allowed to produce on the condition that said work be accomplished.

#### IT IS THEREFORE ORDERED:

(1) That the following wells located in the Mohall Field, Bottineau County, North Dakota, operated by Earl Schwartz, be and the same, are hereby permitted to resume producing.

You have been advised previously that the condition of your leases in the Noonan Field are unsatisfactory. To date you have not made any attempt to correct the situation.


To avoid a shut-in order for your wells in the Noonan Field, their condition must be improved.

### Gentlemen:

I am enclosing a report of the work done in the Mohall Field to date:

# Gehringer #1:

The oil is cleaned up around the tanks from leaking tanks, also diked around the tank battery and treater. Well always was clean. Location good, also set one more 300 bbl. tank as all four wells go in one tank battery.

## Gehringer #2:

Was clean and is.

## Gehringer #3:

Is completed, but shut in under this order. Have not sent in a completion report, as can not until we can produce it as this is also shut in. The drilling pit is not filled in yet as it is too wet.

#### Gehringer #4:

Well is clean and pit filled in This is also a new well drilled in late 1973 and started in March, 1974 Shut in under the No #1 order.

### Mohall Park #1:

This well never was dirty but shut in on account of an overflow pit from the salt water injection well. The Mohall salt water injection well has the pit filled in and a 400 bbl. tank installed for overflow in case the electricity goes off on the salt water pump when other wells were pumping. We also made a dike around this tank.

#### Davis #1:

This well is cleaned up and no pits. Also acidized, report being sent in. Also diked around the tanks.

### RondaRacke:


The pit is filled in and oil spill cleaned. The well is in good shape, also diked around tanks and treater.

#### Rouse:

The well was clean. We filled the small pot hole, as there was no pit on this lease. This well is in good shape, also diked around tanks and treater

The pit is filled in, Miked around tanks, well is in good shape.

Your letter of June 24, 1974, regarding some of your wells in the Mohall Field, is being considered as an application for hearing.


The case will be heard by the Industrial Commission at 9:30 a.m. in the State Capitol Building in Bismarck, North Dakota, on August, 13, 1974.
