### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

Pursuant to legal notice this cause came on for hearing at 8:00 a.m. on the 25 day of June, 1985, in Bismarck, North Dakota, before an examiner appointed by the Industrial Commission of North Dakota, hereinafter referred to as the "Commission."

NOW, on this 11th \_ day of \_ July \_, 1985, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That applicant is the owner of an oil and gas leasehold estate in the  $\rm N/2~NW/4$  of Section 8, Township 161 North, Range 83 West, Bottineau County, North Dakota.
- (3) That said tract of land is adjacent to the boundaries of the Mohall Field, and forms a spacing unit for the Madison Pool, and the spacing for such pool established by the Commission requires wells to be located in the NE and SW quarters of each quarter.
- (4) That applicant is desirous of drilling a Madison test well on said spacing unit located in the approximate center of the NW NW of said Section 8.
- (5) That the well drilled at the proper location on said spacing unit in the NE NW of the section resulted in a dry hole.
- (6) That geological evidence presented to the Commission indicates a well drilled at the proposed location would produce oil that might otherwise not be produced.
- (7) That in order to prevent waste, and to protect correlative rights this application should be granted.

## IT IS THEREFORE ORDERED:

(1) That applicant is hereby permitted to drill a well in the

approximate center of the NW NW of Section 8, Township 161 North, Range 83 West, Bottineau County, North Dakota, as an exception to the spacing requirements in the Mohall Field.

- (2) That applicant shall apply for a permit to drill the above well as required in Section 43-02-03-16 of the North Dakota Administrative Code.
- (3) That the well permitted in (1) above shall not produce more than its fair and equitable share of oil and/or gas in the reservoir.
- (4) That this order shall remain in full force and effect until further order of the Commission.





## Gentlemen:


