ORDER OF THE COMMISSION

THE COMMISSION FINDS:

- (1) This cause came on for hearing at 9:00 a.m. on the 27th day of October, 2011.
- (2) The hearing examiner left the record open to allow Baytex Energy USA Ltd (Baytex) to provide supplemental information in support of this application. The Commission received such information on June 12, 2012 and the record was closed.
- (3) The Commission received an application from Baytex on September 26, 2011 for an order pursuant to North Dakota Administrative Code (NDAC) Section 43-02-03-88.1 authorizing the flaring of gas from the Hansen #13-162-99H well located in the SE/4 SE/4 of Section 13, Township 162 North, Range 99 West, Divide County, North Dakota, Ambrose-Bakken Pool, as an exemption to the provisions of North Dakota Century Code (NDCC) Section 38-08-06.4 and such other relief as is appropriate.
- (4) Pursuant to NDAC Section 43-02-03-88.1, the Director is authorized to sign, on behalf of the Commission, orders relating to, inter alia, flaring exemptions under NDCC Section 38-08-06.4 and under NDAC Section 43-02-03-60.2.

(5) NDCC Section 38-08-06.4 states:

As permitted under rules of the industrial commission, gas produced with crude oil from an oil well may be flared during a

one-year period from the date of first production from the well. Thereafter, flaring of gas from the well must cease and the well must be capped, connected to a gas gathering line, or equipped with an electrical generator that consumes at least seventy-five percent of the gas from the well. An electrical generator and its attachment units to produce electricity from gas must be considered to be personal property for all purposes. For a well operated in violation of this section, the producer shall pay royalties to royalty owners upon the value of the flared gas and shall also pay gross production tax on the flared gas at the rate imposed under section 57-51-02.2. The industrial commission may enforce this section and, for each well operator found to be in violation of this section, may determine the value of flared gas for purposes of payment of royalties under this section and its determination is final. A producer may obtain an exemption from this section from the industrial commission upon application and a showing that connection of the well to a natural gas gathering line is economically infeasible at the time of the application or in the foreseeable future or that a market for the gas is not available and that equipping the well with an electrical generator to produce electricity from gas is economically infeasible.

(6) Baytex Energy USA LTD (Baytex) is the owner or operator of the following well in the Ambrose-Bakken Pool, Divide County, North Dakota:

- (7) The Ambrose-Bakken Pool is an oil reservoir, but gas is produced in association with the oil at the wellhead as a by-product of oil production.
- (8) By previous order of the Commission, said well is currently authorized to flare so that all owners of interests in the well herein described may receive the maximum benefits of the oil production in such a manner that will prevent waste and protect correlative rights.
- (9) The well is not connected to a gas gathering facility and evidence presented to the Commission indicates that the well currently produces approximately 35 MCF per day of surplus gas.
- (10) The well is located approximately 7.5 miles to the nearest gas gathering system although said system is currently operating at full capacity.
- (11) Baytex has submitted evidence that under current market conditions the surplus casinghead gas presently being produced by the well and the estimated recoverable reserves of surplus gas from the well is insufficient to recoup the costs of installing and operating a gas gathering facility.
- (12) Baytex has investigated the possibility of equipping the well with an electrical generator. It is not economic to purchase, installation, connection and operate an electric

generator fueled by produced casinghead gas. The Commission concludes that equipping the well with an electrical generator to produce electricity from the gas is economically infeasible.

- (13) If Baytex's request is not granted, taxes and royalties must be paid on flared gas which will increase operating costs, raise the economic limit and cause premature abandonment of the well; or the well must be connected to a gas pipeline or an electrical generator at an economic loss which would also cause premature abandonment, or flaring must cease and the well must be "capped," resulting in the loss of oil production and the loss of the benefits of that production by all owners of interest in the well and the State of North Dakota.
- (14) Considering the amount of surplus gas being produced by the well, the amount of estimated recoverable reserves from the well, and the cost to connect the well to a gas pipeline, it is not economic at this time to connect the well to a gas gathering facility or an electrical generator.
- (15) Baytex has entered into a contract with a gas gatherer that plans to install a new 270-mile gas gathering system in Divide County that should be operational in 2013.
- (16) In order to prevent waste, and protect correlative rights this application should be granted, although limited in duration.

IT IS THEREFORE ORDERED:

(1) Baytex Energy USA LTD, its assigns and successors, is hereby allowed to flare surplus casinghead gas produced with crude oil from the Ambrose-Bakken Pool through the well listed below under the exemption provided for under NDCC Section 38-08-06.4:

(2) This order is effective as of September 26, 2011 and shall remain in full force and effect until further order of the Commission.

Dear Bruce:

I am writing on behalf of my client, Baytex Energy USA Ltd., in follow-up to your requests for additional information with regard to the captioned pending gas flaring applications.

Baytex's response with regard to each case is identical and is as follows:

- 1. Baytex is currently not aware of an electrical generation system that can operate economically on gas volumes less than 35 mcf/day. Research indicates that a 100KW generator would require a minimum volume of 45 mcf/day. If other potential systems are currently available, then Baytex would welcome information regarding same.
- 2. The economic analysis was only carried out 10 years as the anticipated volume of any excess gas was considered irrelevant to potentially run any type of generator past that point. With the pump jack engine requiring 20-25 mcf/day to operate, no additional gas would be reasonably expected to be available given well

- performance to date. Please refer to additional comments (below) as to Baytex's ongoing electrification program in Divide County.
- As Baytex has limited well performance (to date) to provide a basis for economic limits on a per well basis, it is using a projected model of 170MMCF per well at this time. Until more wells are completed and more data is accumulated, this is, in Baytex's view, a reasonable estimate of ultimate recovery.
- 4. In each case, the correct calculation of total production tax is \$19,550 (\$0.115 x 170,000 mcf) as a mathematical error occurred.
- 5. Although the total of the gross value of gas will need to be adjusted (upward) due to the tax error cited above, this single component does not provide a significant enough change to any economic case to eliminate an undiscounted loss when gas pipeline hook-up and electrical options are fully considered.
- 6. The nearest gas pipeline with sufficient capacity to any of Baytex's wells is Amerada Hess over on the east side of Plumer Township (T161N-R98W) which connects its Moraine 211-1H and Nordstog 14-23 wells.
- 7. Baytex's understanding in the field is the gas lines identified as 4-6 miles from its well locations do not have sufficient capacity to handle additional gas from Baytex. Those systems are full, to the best of Baytex's knowledge.
- 8. Baytex is working on a comprehensive gas gathering system as outlined below.
- 9. Baytex is not in position nor does it have the resources to be a gas gatherer. Although these gas flaring applications happen to be in Ambrose Field and (more or less) in close proximity, they do not reflect the more recent development and broader geographic distribution of Baytex's wells as its drilling and development program has evolved. Baytex has dealt with each well individually and the "big picture" will be addressed regarding its recent gathering contract with OneOK as explained below.
- Baytex and its partner, Samson Resources, have been working in good faith for over a year to negotiate a comprehensive gas gathering system to service its AMI area in Divide County. As a result, Baytex has entered into a contract with OneOK Partners, L.P. from Tulsa, Oklahoma to install a 270 mile system at an investment of \$140-\$160MM to gather gas in Divide County.

11. Baytex has been negotiating with Burke-Divide Coop since the first of this year regarding a multi-step process to install three-phase power for both Baytex and Samson to its acreage block in Divide County. In phase 1 for Baytex, we anticipate the power company will have a new transmission line completed in 4th quarter of 2012 to an electrical substation in Troy Township (T162N-R98W). This will provide the ability to connect (initially) 14 Baytex wells in this first step. After significant improvements to a second substation in Burg Township (T161N-R99W), Baytex will be able to then look at connecting additional Baytex and Samson wells on the westernmost boundary of the Burke Divide service area. Given the wide geographic distribution of the wells and cost of \$70,000/mile to connect to three phase power, this will be an ongoing process over the next several years to judiciously plan and implement a "grid" across the Baytex/Samson leasehold in this remote service area.

Based on the facts presented for the specific cases above and Baytex's attempts with regard to both the gas gathering and electrification challenges faced in Divide County, Baytex does not believe any reasonable analysis would indicate that Baytex is not deserving of immediate approval of the captioned gas flaring applications.

Mr. Bender,

Case 15979 appeared on the Commission's October 27, 2011 docket. This was an application of Baytex Energy USA LTD for an order pursuant to NDAC § 43-02-03-88.1 authorizing the flaring of gas from the Hansen #13-162-99H well located in the SESE of Section 13, T.162N., R.99W., Divide County, ND, Ambrose-Bakken Pool, as an exception to the provisions of NDCC § 38-08-06.4 and such other relief as is appropriate.

The Commission has the following questions concerning the affidavit Ward Rikala submitted on October 25, 2011 in support of Case 15979:

- 1. Baytex indicates an electric generator fueled by gas produced by Hansen #13-162-99H well (File #18728) is not applicable as gas available as fuel at 35 mcfpd is insufficient to power an electric generator of any significance.
 - a. It appears from the affidavit that an electric generator is available that could operate on 35 mcfpd. The Commission needs economic information on such connection.
 - b. Why is the economic analysis only considered for a 10-yr period?
- 2. Baytex estimated the ultimate recoverable gas reserves for the well at 170 MMCF, which was identical for Cases 15981-15986 (other Ambrose flaring cases on the docket).
 - a. Why wasn't the ultimate recovery calculated based upon an economic limit for each individual well?
- 3. The calculation of total gas production tax is \$96,400.
 - a. It appears this calculation is in error since a tax rate of \$0.115/mcf X ultimate recovery of 170,000 mcf = \$19,550, not \$96,400.
 - b. The total gross value of the gas reserves will be incorrect if the tax is incorrect.
- 4. Baytex estimated the distance to the nearest connection point to a gas gathering facility with sufficient capacity to market the gas to be 7.5 miles.
 - a. There are wells as close as 4 miles to the north that are connected to a gasline. Why can't this well be connected to the same system?
- 5. Baytex conducted an economic analysis on each well individually assuming the entire cost of bringing a gasline into the Ambrose field had to be paid by the single well.
 - a. This case and Cases 15981-15986 are Baytex applications all in the Ambrose Field in close proximity to one another. Why wasn't the cost to bring the main gasline into the field evaluated using all surplus gas produced in the Ambrose Field?

Ward Rikala, being first duly sworn, deposes and states as follows:

1.

That I am the Production Manager for Baytex Energy USA Ltd., 600 17th Street, Suite 1600S, Denver, CO 80202, the applicant in the above-entitled matter.

2.

That I have prepared or had prepared under my control and supervision the attached exhibit.

3.

That to the best of my knowledge and belief, the information contained on the attached exhibit is true and correct.

That attached as Exhibit No. 1 is a plat showing the area around the Hansen 13-162-99H well. Shown on the plat is a line depicting the field limits of the Ambrose-Bakken Pool, as defined by the North Dakota Industrial Commission. Also displayed on the plat is the location of the Hansen 13-162-99H well located in Section 13, Township 162 North, Range 99 West, Divide County, North Dakota.

5.

That Baytex is currently the operator of the Hansen 13-162-99H well, said well having been completed and producing in the Ambrose-Bakken Pool.

6.

That to the best of my information, knowledge, and belief, the Hansen 13-162-99H well was completed as a producer on or about <u>July 28, 2010</u>.

7.

That to the best of my knowledge and belief, gas produced from the Hansen 13-162-99H well from the Ambrose-Bakken Pool does not contain any H₂S and is considered sweet gas.

8.

That to the best of my knowledge and belief, the current average daily rate of gas being produced from the Hansen 13-162-99H well is approximately 55 MCFD.

9.

That the Hansen 13-162-99H well is currently not connected to a gas gathering facility.

That to the best of my knowledge, belief and information, the costs associated with the purchase, installation, connection and operation of an electric generator fueled by gas produced from the Hansen 13-162-99H well is not applicable as gas available as fuel at 35 MCF/day is insufficient to power an electric generator of any significance.

11.

That to the best of my knowledge, belief and information, the projected revenue received from sale of electricity produced from the electric generator fueled by gas produced from the Hansen 13-162-99H well over a ten (10) year period is not applicable in this case.

12.

That requiring the installation and operation of an electric generator fueled by the gas produced from the Hansen 13-162-99H well is not mechanically or economically justifiable.

13.

That to the best of my knowledge and belief, the total amount of gas from the Hansen 13-162-99H well not being used for lease use and available for sale is approximately 35 MCFD.

14.

That gas produced in association with oil produced from the Hansen 13-162-99H well and not utilized for lease use is currently being flared.

15.

That Baytex estimates the ultimate recoverable gas reserves from the Hansen 13-162-99H well to be 170 MMCF of gas, produced over a 30 year well life.

That based upon the sale of gas from other wells connected to the nearest gathering system with sufficient capacity to service the Hansen 13-162-99H well, if said well were connected to a gas gathering facility, it is anticipated that said gas would have a value of \$4.93/MCF.

17.

That based upon the aforementioned price of \$ 4.93/MCF, the gross value of the recoverable gas reserves from the Hansen 13-162-99H well is estimated to be \$838,100.

18.

That based upon a royalty rate for the Hansen 13-162-99H well of 20% and a gas production tax of \$0.115/MCF, Baytex estimates the royalty and production tax burden for the total (gross) gas produced from the well would be approximately \$167,600 and \$96,400, respectively.

19.

That the total (undiscounted) gross value of the gas reserves of the Hansen 13-162-99H well to the working interest owners, after deducting royalty and production taxes, is approximately \$574,000.

20.

That to the best of my knowledge and belief, the Hansen 13-162-99H well is located approximately 7.5 miles from the nearest connection point to a gas gathering facility with sufficient capacity to market the gas.

21.

That based upon the operations of other operators in and near the area of the Hansen 13-162-99H well, the cost associated with the purchase and installation of a two inch pipeline from the well to the nearest connection point to a gas gathering facility is approximately \$100,000 per mile. In this case, the total cost would be approximately \$755,000, inclusive of a gas meter.

22.

That based upon the differential between the gross value of the gas and the cost to install and operate the pipeline required for delivery of gas to a gas gathering system, requiring to connect the Hansen 13-162-99H well to a gas gathering system with sufficient capacity would result in an undiscounted loss of approximately \$181,000.

23.

That based upon my knowledge and belief, the low volumes of gas produced from the Hansen 13-162-99H well make it economically infeasible at the present time or in the foreseeable future to connect the Hansen 13-162-99H well to a suitable gas gathering facility.



Baytex Energy USA Ltd. ("Baytex"), for its application to the North Dakota Industrial Commission ("Commission"), respectfully states as follows:

1.

That Baytex is the owner of an interest in the oil and gas leasehold estate in portions of Section 13, Township 162 North, Range 99 West, Divide County, North Dakota.

2.

That such lands are currently within an area defined by the Commission as the field boundaries for the Ambrose-Bakken Pool.

3.

That Baytex is currently the operator of the Hansen 13-162-99H well located in the Southeast Quarter of the Southeast Quarter (SE/4SE/4) of Section 13, completed as a producing well in the Ambrose-Bakken Pool.

4.

That the Hansen 13-162-99H well is currently not connected to a gas gathering facility.

That because of the location of the well and low volumes of gas produced from the Hansen 13-162-99H well, it is economically infeasible to connect said well to a gas gathering facility at the present time, or in the foreseeable future.

6.

That gas produced in association with oil produced from the Hansen 13-162-99H well is currently being flared.

7.

That Section 38-08-06.4 of the North Dakota Century Code prohibits the flaring of gas produced in association with crude oil under certain circumstances but authorizes the Commission, upon application, to grant an exception to the flaring prohibition upon a showing that connection of the well to a gas gathering facility is economically infeasible at the time of the application or in the foreseeable future or that a market for the gas is not available.

8.

That in the opinion of the applicant, it is economically infeasible at the present time or in the foreseeable future to connect the Hansen 13-162-99H well to a gas gathering facility and/or there is no market for the gas. As such, applicant should be allowed to continue to flare such gas as an exception to Section 38-08-06.4 of the North Dakota Century Code should be granted for said well.

WHEREFORE, Baytex requests the following:

(a) That this matter be set for the regularly scheduled October 2011 hearings of the Commission;

- (b) That pursuant to Section 43-02-03-88.2 of the North Dakota Administrative Code, Baytex's witnesses in this matter be allowed to participate by telephonic means; and
- (c) That thereafter the Commission issue its order granting the relief requested and such other and further relief as the Commission may deem appropriate.
