1. Form of Bids. Bids must be submitted on the enclosed bid form.

3. Examination of Equipment. Prospective bidders are encouraged to make a visual inspection of the salvaged well equipment to ascertain the nature and condition of the equipment. Please contact Dave Hvinden with the NDIC Oil and Gas Division at 701-328-8027 to make arrangements to view the equipment. A partial listing of the equipment with estimated count of tubulars and rods is attached.
4. Terms of Sale. The Commission has title to all equipment on the sites and will provide a bill of sale to the successful bidder upon receipt of payment. Payment by the successful bidder must be in the form of cashier's check or certified check. All equipment is offered in "as is" condition and there is no other expressed or implied warranty or guarantee.
5. Bid Deadline. All bids are due in the office of the Industrial Commission, Oil and Gas Division, by 11:00 a.m., January 5, 2015. The office is at 1016 E. Calgary Ave., Bismarck, ND. Bids received after this deadline will not be considered.
6. Review of Bids. The public opening of the bids will be held at 11:00 a.m. January 5, 2015, at the Industrial Commission, Oil and Gas Division, 1016 E. Calgary Ave., Bismarck, ND.

7. Withdrawal of Bids. Bids may be withdrawn by bidder's written request received prior to the time set in paragraph 5.
8. Rejection of Bids. The Commission may reject any and all bids.
9. Notification of Bid Acceptance. The successful bidder, if any, will be notified of the acceptance of the bid within ten days after the bid opening.
10. Cancellation of Bid Acceptance. The Commission may cancel the bid acceptance at any time before payment is received and accepted by Commission, without any liability to the Commission.
