Basic Subscription: The GIS map server, a complete index of all wells permitted in North Dakota in a Microsoft Excel spreadsheet saved with Zip compression. The scout ticket data contains basic well information, log tops, completion data, initial production tests, cumulative production and injection volumes, drill stem test recoveries. The well files are scanned into Adobe PDF documents that include all forms, letters, geological reports, drill stem test reports, core analysis reports, and other miscellaneous information. All well files are available, except for confidential wells or confidential information. Production and injection histories are available on a well, unit or field-pool basis. \$50.00 per year

Premium Subscription: Includes all information in the Basic Subscription, plus oil and gas field orders, scanned case files, hearing audio, digital and image well logs, NDIC log tops, cored intervals, core photographs, thin section photographs, stripper well determination assistant, unitization statistics, processed gas plant volumes, performance decline curves, and statewide well production. \$175.00 per year

No Charge Services: GIS map server, current drilling rig list, rules and regulations, daily activity reports, fill-in forms in Adobe Acrobat PDF or Microsoft Excel formats, hearing dockets, live hearing web casts, statewide monthly and annual production statistics, drilling statistics, seismic activity, searchable basic well data, surface owner notice. Our GIS web page includes the following: basic well data with lateral and directional legs, field and unit boundaries, inspector areas, State, Federal and Indian lands, and aerial photos.

Monthly Production Report
Posted on Web – No charge service

This report includes a list of all wells capable of producing for that month. This well list includes monthly production totals (oil, gas, and water), number of days produced, and runs and lease use for that month, all sorted by field, pool, and operator. A list of permits issued during the month is also included at the end of the report.

Log Tops of North Dakota on CD-ROM

Selected log tops were picked using all available logs in the files of the Oil and Gas Division. Tops used are those generally recognized, but some interpretations may vary and some are difficult to pick with consistency across the state. The general rule was to omit tops unless we were relatively confident of the pick. Computer entries have not been checked for errors.

The tops are in Microsoft Excel format.

Cost - \$25.00

Continuous Well Log Copying

This service provides a continuous paper copy of all well logs in our library. All orders should include the well location and preferred log type.

Cost - \$.10 per copied linear foot (subject to change).

Digital and Image Log Availability

Previously scanned well logs in the NDIC Oil & Gas Division's inventory are available on CD ROM at a cost of \$8.00 for the first scanned log and no charge for each additional log requested from the same log suite. If you prefer, these logs may be e-mailed to you at a cost of \$3.00 for the first log scan and no charge for each additional log requested from the same log suite. (Please check with your e-mail service provider to verify that maximum file attachment size restrictions will not inhibit e-mail delivery of logs.)

For requests where paper logs must be pulled from the NDIC Oil & Gas Division's inventory, there will be a \$15.00 fee, which will include a scanned image of one well log on CD ROM. There is no charge for each additional log requested in the same log suite. If you prefer, these logs may be e-mailed to you at a cost of \$10.00 for the first log scan and no charge for each additional log requested from the same log suite. (Please check with your e-mail service provider to verify that maximum file attachment size restrictions will not inhibit e-mail delivery of logs.)

Some well logs are available as digital Log ASCII (LAS) formatted files for \$3.00, plus no charge per log trace. These may be provided on CD ROM or e-mail.
